I. SPECIAL SESSION

A. Call to Order

Mayor Ysusi called the meeting to order at 9:00 A.M.

II. ITEMS FOR COMMISSION ACTION

A. Consider hiring a consultant to provide the code and plan review for 223 W. Main Street.

Mayor Ysusi reported that three proposals were received by the Commission and reviewed each proposal.

Commissioner Caflisch reported that he had contacted four firms after the last Commission meeting and had received proposals from three of the companies he had contacted. He continued with a review of each firms pricing and the scope of work of each proposal.

Mayor Ysusi asked about the timeframe for this review to take place.

Commissioner Caflisch replied that FSC could begin August 9, Ross and Barzini gave a two-week completion, and Poole Fire Protection could begin as soon as the contract is awarded to them.

Mayor Ysusi noted that Poole Fire Protection had the low bid and could start immediately.

Commissioner Hogsett noted that he had not heard of any of these firms and was willing to take Commissioner Caflisch's advice. He added that he was upset that the Commission was bypassing city staff on this issue and noted that the owner of Indy Brew Works was in the audience and wondered if he had anything to say about this.

Commissioner Caflisch added that he called the Office of Property Management in Topeka that handles the projects for the State and visited with one of the members in charge of selecting architects and engineers and asked him to give him names of firms that they recommend.

Robert Box, owner of Indy Brew Works asked if they would be allowed to install their gas burners.

Commissioner Caflisch replied that the Commission's action doesn't restrict him from procuring his material.

Mr. Box asked who is responsible for issuing the occupancy permit.

Commissioner Caflisch replied that the permit would come from the City.

Mr. Box noted that they had just installed their glycol chiller lines and asked if they could get that inspected now or do they have to wait for the review to be completed.

Commissioner Caflisch noted that equipment installation is not under review.

Motion:

On the motion of Mayor Ysusi, seconded by Commissioner Caflisch the Commission approved hiring Poole Fire Protection, Inc. to perform Code Compliance Plan Review and Inspection services regarding 223 W. Main Street in the amount of \$8,230.00 to be funded from the General Fund.

Commissioner Caflisch suggested that the Commission have a discussion regarding the fee to be charged to the building owner.

Director Cowan presented a fee schedule to the Commission and noted that City Code does allow for additional plan review to be charged to the building owner.

Commissioner Caflisch noted that although the City could justifiably charge the building owner, he doesn't feel comfortable charging any of the cost to the building owner.

Commissioner Hogsett agreed and felt that it would be awkward to charge them after bringing in a third party.

Mayor Ysusi agreed as well.

Commissioner Caflisch noted that after the findings are set and the contractor does not abide by those findings, any additional inspection should be charged.

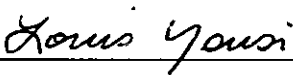

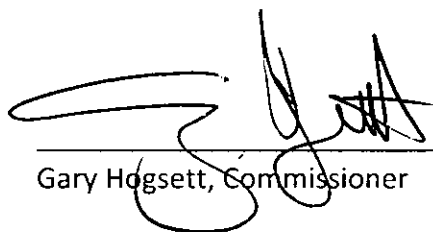

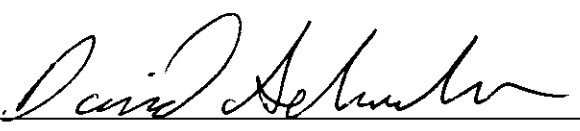
