III. ITEM FOR COMMISSION ACTION

- A. Consider an amendment to a purchase and sale agreement regarding land in the West Laurel Industrial Park and any additional related action.

Representatives of the Economic Development Advisory Board, Montgomery County Action Council (MCAC), the State and City staff have been working with developers for the potential construction of a distribution facility in the West Laurel Industrial Park on approximately 36.1 acres. The agreement provides for the property to be purchased at an incentivized price of \$5,000 per acre, for the extension of municipal utilities and Enterprise Drive to the site. Per the agreement, the maximum cost for public infrastructure improvements is \$1.1 million. Grant opportunities will be sought as applicable. If any grants are awarded, they will be brought back to the Commission for final acceptance.

On the motion of Commissioner Hayse, seconded by Commissioner Caflisch the Commission authorized the Mayor to sign any related documentation regarding an amendment to a purchase and sale agreement approved on June 10, 2021 to sell land in the West Laurel Industrial Park to JDKS Bundle LLC pending the City Attorney's review and approval.

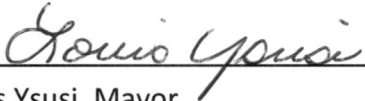

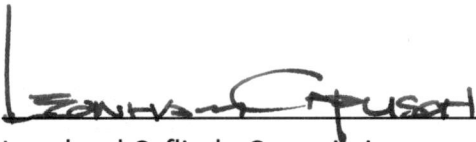
